Gregory Summers, a 37-year fire service veteran, was hired to lead the Waco Texas Fire Department in March of 2020.

As Fire Chief, he manages a \$30,000,000 budget and a workforce of 207 Civil Service employees and eight civilians. Chief Summers hails from Little Rock, Arkansas. He served 35 years with the Little Rock Fire Department, serving in many capacities within the department, most notably Fire Chief during his last nine years, as Little Rock's First African American to serve in that post.

During his tenure as Little Rock's Fire Chief, the department had several accomplishments. Most distinct-

ly, attainment of Insurance Services Office (ISO) Class 1, the highest designation a fire department can achieve and International Accreditation through the Center for Public Safety Excellence. Of the 29,980 fire departments in the United States, only 87 or 0.2%, share this dual distinction.

In his spare time, Chief Summers enjoys traveling in his motor home. He is a member of Omega Psi Phi Fraternity Inc and holds a BS Degree in Emergency Management Administration and an AAS Degree in Fire Science.


Working it out is just what He does

#### Sankofa by Chibundu Onuzo, a book review

Chibundu Onuzo, who was born in Lagos, Nigeria, and lives in London, is also a fellow of the Royal Society of Literature. She has been listed for a number of prestigious prizes for literature. Sankofa is her first novel.

Sankofa is a wonderful story of a mixed-race woman who goes in search for the African father she never knew. Her journey is funny with a fascinating turn while learning about her ancestors.

The book opens, "My mother was gone six months when I opened the trunk I found under her bed. I opened the trunk on the same day her headstone was erected. Rose, my daughter, accompanied me to the cemetery. I wore black, like it was a second funeral. Grass had grown over her grave, the earth erasing all memory of its disturbance. The headstone was marble, paid for by my mother's funeral insurance" // Bronwen Elizabeth Bain 1915-2018 / Beloved Mother, Grandmother, Daughter and Sister. Remember me when I am gone away, Gone far away into the silent land. // The Rossetti quote was a touch melancholic, but so was my mother and, for that matter, so was Rose. We laid flowers, fresh white

chrysanthemums. Rose said a few words, addressing my mother as if she was present. When she finished, she turned to me. I school my head. The practice felt too foreign and fanciful" (3). The family gathered for a luncheon.

An old box was awaiting its opening. "The trunk looked old. Brass fastenings and studs. Rose would have called in vintage. I avoided it for a long time. I had not enjoyed my previous experience of sorting through my mother's things. There had been no catharsis, only a strange fatigue after holding the clothes she had worn and the books she had read. It became clear I did not know her very well. Madame Bovary was on her bedside table. In the recesses of a wardrobe, I found a pair of sequined gloves" (4). Chibundu felt the loss as does everyone at such a moment. This paragraph is nearly identical to my own mother's recent passing.

The story continues, "In the months I avoided the trunk, it occurred to me that information about my father might be inside. I was very curious about him in my childhood. I knew his name, Francis Aggrey. I knew that he had arrived in England in the late sixties to go to university. I knew

he had lodged in the spare attic room of my grandfather's house, and that he and my mother had some sort of affair. When he returned to his country, Bamana, she didn't know she was pregnant with me. They never saw each other again. By the time I was eighteen, I'd stopped trying to find out about him. Although, once in a while, I would daydream about traveling to Bamana, stopping strangers in the street and asking if they knew a Francis Aggrey. I don't remember when that dream died. I'd gone through all the photographs. The boxes looked empty. I shook it and heard sliding, objects rubbing against each other. I turned the trunk upside down and banged it. A false cardboard bottom came loose. Two notebooks fell out along with a black-and -white photograph the size of a playing card" (5).

Now the mystery begins. "I opened the first notebook, cheaply bound and filled with the same tight script. London is afraid of me. Black man cannable. Black man rapist. Hide your fat wives and your dumpy virgin daughters. Shut your door in my face. Look out. Toland Man is coming. The author's voice was strong and alive, as if he had walked into the room and began speaking. An intelligent Blackman, angry, humorous. Surely not my father, hidden away in this box by a woman who told me there was too little to know but his name" (6).

The adventures lay ahead! "I shut the diary. I did not want to meet my father in one citing. I put the scrapbook and loose photos in the box. I kept the books and Francis Aggrey's photograph. I double locked my front door and checked if the kitchen window was shut. I left the stair lights on to show I was awake and in lunging distance of a panic button. Next year, perhaps, I would sell the house and move to a flat with other families stacked like

crates above and below me. I went upstairs to my bedroom. I changed into my sexless pajamas and turned off the lights. I still slept on one side of the bed, pinned to my half of the sheets, facing the space my husband once occupied. In the mornings, one side was always ruffled, the other smooth as an egg: portrait of a single woman's bed" (8).

Finally, Francis makes a connection with a woman. "I have made friends with one of Menelik's secretaries. She is a bookkeeper during the week but comes to Menelik's flat on Saturdays to lend her hand to the liberation. She is the first obroni woman I have spoken to in any depth. Her hair is the color of ripened tomatoes, which makes her almost as rare as I am on the streets of London. I ask why she cares so much about Africans. She says she is from a colonized people herself. By that, she means she is Welsh" (17). Anna continues, ""A redheaded, radical Welsh bookkeeper. It must be Aunt Caryl! So absorbed was I in Frances's London life that I had almost forgotten that he must meet my mother at some point" (17).

#### State & local efforts promote access to college

In 2019, the 86th Texas Legislature passed House Bill 3 with the aim of increasing college enrollment among graduates. As part of the initiative, students must now complete FAFSA and TASFA student aid forms or opt-out of the financial aid process in order to graduate high school.

FAFSA (Free Application for Federal Student Aid) is an application that students and parents fill out in order to receive state or federal aid. Undocumented or DACA students may fill out the TASFA (Texas Application for State Financial Aid) in hopes of receiving state funding.

Most students who qualify for state or federal aid are from low-economic backgrounds or

are first-generation students. Thus, HB 3 has the potential to increase diversity and inclusion within college enrollment

Only 20% of students in McLennan County have completed their financial aid ap-

plication, according to Educate Texas.

McLennan County has taken great steps to increase this percentage. The MAC College Money Program has hosted financial aid workshops for high schools across the county. The College Achievement Program (CAP), as part of VOICE, is assisting schools by meeting with students individually to complete their financial aid forms.

In February, a community-wide financial aid night event will be held to assist parents and students with the process of applying for financial aid. Through community initiatives, students and parents will have the resources available to complete their financial aid process and meet this graduation requirement.

#### There's another open enrollment period

Most Medicare beneficiaries are not aware that there is another Open Enrollment Period. This enrollment period is not normally discussed but is available for any Medicare beneficiary who is currently in a Medicare Advantage plan. It is a relatively new enrollment period that last from January 1st to March 31st.

If you are enrolled in a Medicare Advantage plan during that time but are in a plan that doesn't quite suit your needs, you may change to a more suitable plan or go back to Original Medicare.

Your plan may not continue serving your needs for several reasons. You may have signed up for a plan during the Annual Enrollment Period without checking to see if your Primary Care Physician or Specialist was In-Network or they may have decided not to continue being In-Network.

Perhaps you have changed providers due to special healthcare needs and those particular pro-

Another reason you may

decide to change plans is that you may have been diagnosed with a new ailment and your new medication is not on the current plan but is available with another plan.

Whatever your situation, you can look during the Medicare Advantage Open Enrollment Period to see if another plan suits your needs better.

Unlike the Annual Enrollment Period where you can change several times before the December 7th deadline, during the Medicare Advantage Open Enrollment Period, you may only change once. #### Encourage students to "shoot for the moon"

"Shoot for the moon, mijo," my mother said to me when I was a child (a "mijo"). Born in Colombia, she had shot for the moon herself when she immigrated to Texas as an 18-year.old.

She and my father consistently opened doors of opportunity for their kids and encouraged us. They spent their lives giving my sister and me access to many things they did not have growing up. We were not rich by any means, but our family did not go without because of my parents' blue collar work ethic; one they ingrained in me.

My parents made it possible for my sister and me to participate in and enjoy sports, music, clubs, and vacations. Most importantly, they gave us access to college. I didn't quite understand why college was so important, but I knew it was the expectation. Thanks to the environment my parents created, I was on the path to college.

When I completed my bachelor's degree at Stephen F. Austin State University, my parents were so proud of the achievement, but I still wondered why it was a big deal. It dawned on me later that it was due to the lack of access they had in their lives. They did not have an opportunity to go to college, but they knew how a degree would change the trajectory of future generations.

Fast forward a bit and now I have a master's degree and a better understanding of their sacrifice. I now know, also, what access means for future generations of Pereiras.

I was fortunate enough to have supportive parents who opened the doors for educational access, but not all students have those opportunities. When I look at educational data for our community I can see myself in it based on my experiences. As a high school teacher, coach, and principal for 15 years I witnessed these same paths in my students. I tried my best to channel the words and actions of my parents with my students.


The Texas Higher Education Coordinating Board conducted a study where they followed an eighth-grade cohort through their graduation from high school and college. The results were eye opening. It showed that only 28% of McLennan County eighth graders completed a post-secondary credential (college or other credential) six years after high school graduation.

These numbers highlight the gaps that exist in our college and career pipelines.

- How are we preparing our students for their futures?
- What career opportunities are they exposed to?
- What financial aid services are available for their schooling?
- How do enrollment numbers look for students in our county?
- How are students in our county persisting and are they completing their degrees?

The eighth-grade cohort study shows that 72% of our students did not have a solid plan for their futures. Are we as a community opening the doors for college access for all students, from all districts, from all neighborhoods? It's a tough ques-

tion to ask but it's necessary to understand where we are doing well and where we have room to improve.

Our future workforce is sitting in classrooms today. Are we doing all we can to open their doors of access?

Our local school districts, higher education institutions, and community partners are working on opening access, but there is more work to be done. Prosper Waco is engaging in strategic conversations around the systems that are in place for improved college access in our community. In 2022, we plan to launch new projects and partnerships that will bring more access to students and their families who are the future of our community. Will you join us in this work?

I hope we can encourage today's students to "shoot for the moon" and then to help them to do it.

You can join in this work; schools alone are illequipped for this task. I had parents encouraging me, but some of our students do not have such support. If you want to join this con-







#### Observance of Pearl Harbor's 80th anniversary includes tributes to hometown hero

Beneath a clear blue sky, over 200 Wacoans commemorated the eightieth anniversarv of the attack on Pearl Harbor at the Doris Miller Memorial on the banks of the Brazos River. The service started at 11:55AM, the local time on December 7, 1941 when the Japanese attacked the naval station in Hawaii and Doris Miller, an African American sailor from Waco, performed the heroic deeds that would result in his becoming the first African American serviceman to win

the Navy Cross.

In the eight decades since the surprise attack at Pearl Harhor Miller's actions have become well known. Like most African American servicemen, he was relegated to menial duties such as mess attendant or laundry work, because African American sailors were considered inferior for combat. Thus, Miller was not trained for combat duty on battleships. Nonetheless, when the Japanese attacked, despite his lack of training, Miller jumped into action, first pulling the badly wounded captain of the USS West Virginia out of danger and then hauling sailors who had been blown overboard from the ocean. Finally, he manned an anti-aircraft gun, firing at the attacking Japanese planes. And in so doing, fought his way into the annals of American history shattering racial stereotypes in the military and broader society.

Participants in the ceremony included Pastor Carlton Stimpson of the Open Door Church of God in Christ, La Vega High School's Navy Junior Reserve Officer Training Corps, Commissioner Patricia Chisolm-

Miller, and the Waco Community Choir. Waco Mayor Dillon Meek, former Ambassador Lyndon Olson, Jr., and Doris Miller's great-nephew gave remarks. The event featured a flag presentation and a wreathlaying ceremony conducted by Steve Cook, state treasurer of the American Legion, Department of Texas. In addition to members of Miller's family, veterans, and active duty military from around the state and the country attended the ceremony, including members of the New York American Legion post named for Miller.

Several new bronze reliefs depicting Miller's life were unveiled. Designed by sculptor Eddie Dixon, the reliefs depict Miller's early life in a share-cropper's family, his athletic life, and his heroic actions to save the ship's captain. The reliefs were installed around Dixon's statue of Miller where family members, American Legion members, dignitaries, and the general public posed for photos before and after the observance.

Doris Miller's great-nephew Thomas Bledsoe, Jr. addressed attendants on behalf of the sailor's family. He thanked Waco for honoring his great-uncle. He remarked that his great-uncle "humbly rose to the occasion" echoing the words of City Councilwoman Andrea Barefield when the memorial was first dedicated. At the time, Barefield stated that on the morning of the Pearl Harbor attack, Miller did not awake thinking that he was going to become a hero. He simply went about his duty, and in doing so, became a hero.

Bledsoe explained how Miller's legacy had been passed to the younger generations of his family. "I remember the words of my grandfather like they were yesterday. He said, 'Thomas when you walk into a room, remember many before you have unlocked the door, and if a door is locked, you have a responsibility to unlock it, walk through it and keep it unlocked for others," Bledsoe said. "His words resonated with me because he connected it with what his brother had done at Pearl Harbor." The family continues the campaign to convince Congress to award Doris

Miller the Medal of Honor. Former Ambassador son, who was instrumental in bringing the memorial to reality, remarked that Miller's legacy would go on. "He was recognized as one of the first heroes of World War II," Olson said. "In his heroism and selflessness, at a time when Black men were less thought of, he elevated his race. ... He brings and has brought to Waco more recognition for such great deeds than we have a right to ask for. This memorial stands on the banks of the Brazos River and it graces this river with its presence and is surrounded by so many others who answered their call to the country. He stands close to the bridges, who have their own history, seen in the segregated South. There is a certain poetry that both of these parts of history now stand side by side, hopefully fulfilling what Doris Miller, who lost his life in the service of his country, would want to be remembered for - a place of healing and enriching others."



#### Punching the clocks of toxic work environments

Workplace bullying. Toxic work environment. Stressful. Hostile work environment are terms associated with unhealthy psychological and physical conditions in professional settings of employment. With safeguards in place to prevent workplace abuses, it continues to happen at alarming rates. I spoke extensively to individuals who personally understand what these terms mean, how it feels, and the insurmountable toll it takes. During the conversations, clear patterns emerged. Based on competition for advancement, hierarchy, financial circumstances, social, cultural diversity, and age, conditions and behaviors seemed to happen the same way, regardless of geographic locations, organizations, and income. What's evident is, the toxic work environment extends beyond working hours. It comes home. It infiltrates sleep. It occupies every waking thought, and it is insidious to one's health and survival. Consistent days of frustration, fear, heartbreak, anger, and communication breakdowns are symptoms of an internal crisis brought on by an external problem. When that crisis is tied up with financial stability, it is an unbearable burden.

Workplace abuse, hostility, coercion, unfounded accusations, stalking, and joking around, singles out an individual to isolate and silence. For a young person striving for independence and financial freedom, there are no words to describe the fear, loneliness, shame, and horrors of what it does internally. Without knowing it, a soldier had been singled out at her workplace by someone who had more seniority. The soldier in the senior position had access to her phone number and used it for purposes other than professional communication. His advances were unaccepted. Because family members of the female soldier kept regularly scheduled contacts with one another. it set off alarms when their calls went unanswered. She reported the harassment on her job and spoke about it to family members who listened and maintained the lines of communication and support. When that link of established communications was broken, her family knew instantly something was wrong. An investigation ensued into the disappearance of Vanessa Guillen. Because of details she shared during those conversations, piecing together what went on helped authorities find those responsible for death. Because she dared to share, oth-

ers came forward. Creating regular links of communication is very necessary.

Whenever anyone is referenced as a "troublemaker," "whistleblower," "pariah," "snitch," and other words of an inflammatory nature, it's extremely hostile, and serves to isolate and target. Intimidation affects everyone within listening range causing feelings of being disrespected and unsafe. Hostility of that nature spills into social circles causing others to distance interactions or face the same types of treatment. Social isolation reduces productivity, teamwork, and trust. In the words of artist, Roshanda Prior, "Everyone in the organization does not represent the organization and what it stands for."

Cyberbullying by a co-worker is one of the ways workplace extends beyond the walls. A case of harassment had been reported. The person who received the report went to the next person in charge to handle the problem. That individual had images on a handheld device. The images on the device had taken the

head from a social media account pasted to the body of someone in swimsuits. When the subject of harassment came up, the images were presented as a way to undermine the credibility of the person who reported. Because the individual who had the images was also one in authority, the problem became compounded. The person who initially reported had images passed around, the person who reported to the next in charge became the next obiect of attack. In that case, minor family members became the target used to make the grievance go away. Based on false statements, a mother was wrongly accused of harming her child, as a result of doing her job. Once it was proven the allegations were false, threatening phone calls began. By not knowing where the threats originate, she became more of a social recluse.

Quitting is not always an option when employment is contracted. It isn't always an option when the workplace is the primary source of income, or the opportunity for promotion is within range. If an investigation is ongoing the option to quit is typically removed as a solution. After discussing what contributing factors look like, I was informed of instances where groups of individuals have been recruited to send a strong message, in the form of physical violence to individuals who report or file grievances.

Workplace culture is the primary source where toxic work environments fester. To dismiss concerns as petty, drama, or irrelevant is violent. It deserves the attention of those in positions of authority. Anyone who receives

reports regarding conflicts, equal opportunity concerns, safety, need to be carefully vetted. They cannot be part of the problem. Creating systems for anonymous reporting not just locally, has to be available. When organizational or corporate funding is tied up with reporting crimes then, jobs will no longer be a safe haven for those with criminal intent. Character assassination needs to be given the same weight for litigation as harassment, discrimination, and assault. To alienate coworkers is a form of abuse. Call it out and refuse to participate in it.

Breaking the cycle begins with everyone who enters the workspace. Anyone who has to endure an unhealthy work environment must be prepared to stay and see it though. Yes, it does cause psychological trauma, but there are solutions to alleviate the gut punch.

The first thing is to establish a line of trust and communication with someone outside of the job. To support, that person needs to listen, write, or record the conversation. Get counseling. Keep a journal or diary of some kind. Establish a routine of communication weekly, daily, and make sure that the person(s) can call a friend close to you whenever they don't hear from you. If possible, use cameras and video devices vou can access from anywhere. Use electronic devices to track your movements. For every meeting, write dates, time, locations, and

Be safe. Be confident, and let's do our parts to create safe and healthy work environments. These conversations will continue.

Through Christ, God's power to keep the church in times like these is manifested for the church to experience and the world to observe. It was the Apostle Paul who exhorted us to stand even in times like these. He instructed the church of the Ephesians that they should stand having done all to stand.

As I bid you, the Church, a Merry Christmas, I write the instructions that the apostle wrote that ye might be able to stand in these evil times. (Ephesian 6:13 Wherefore take unto you the whole armour of God, that ye may be able to withstand in the evil day, and having done all, to stand.14 Stand therefore, having your loins girt about with truth, and having on the breastplate of righteousness;15 And your feet shod with the preparation of the gospel of peace;16 Above all, taking the

God will bless the hearers and doers of his words even in times of sorrows. Amen!


