Albert Hunter has been a teacher in the public school system for 27 years both as a full-time teacher, part-time teacher and now, as a substitute teacher.



We are just days away from being able to cast our vote, and voters need to prepare themselves to vote. Despite the fact that many—in and out of government—are working to suppress the vote, Texans' can vote with just a bit of effort.

The Project VIER Coalition will be distributing *Plan to Vote* cards with election information in churches, barber shops, salons, businesses, libraries, colleges, and more. Look for the NAACP logo for trustworthy info.

#### **EARLY VOTING**

Beginning Monday, October 21, voters can begin to vote at five vote centers around McLennan County. On the only Sunday of early voting, folks can join the community for Souls to the Sunday and vote together at the

Multi-Purpose Vote Center on Quinn Campus. Why wait? Vote early! Voters who vote early will be assured that their votes are cast. Significantly, early voters have the opportunity to get problems corrected before it's too late. Call the NAACP Elections Helpline with any problems (254-754-7001).

#### **VOTE CENTERS**

Vote centers are voting sites located around the county (that's 46 sites) where voters can vote no matter what your precinct is. Thus, if you live in Hewitt but work in Bellmead, you may vote at the Bellmead Civic Center. If you live in Bellmead but work in Hewitt, you may vote at the Hewitt City Hall/Library. That is, you can vote at any of the 46 vote centers on Election Day and five during early voting. Go to McLennanVotes. com to locate a vote center.

#### **VOTING BY MAIL**

Qualifying voters who intend to vote by mail should immediately request an application to receive a mail ballot (Call the Elections Office-254-757-5043). They should complete and return the application as soon as they receive it. When voters receive their ballot, they should immediately complete it and put it in the mail being sure to follow all instructions. The McLennan County Elections Office has already begun mailing ballots to voters who requested them. Should voters want to return their mail ballots in person, the only day to do that is on Election Day, November 5 at the Elections Office on 4th Street, and the voter must return the ballot himself or herself. Elections Staff will come to a voter's vehicle to collect the ballot. Voters should bring their identification with them to turn in a mail ballot.

#### CURBSIDE VOTING

Voters should be aware that curbside voting is available at every vote center during early voting and on Election Day. Voters can send someone in to a vote center to alert election workers. If they have no one to alert election workers,

they may call the Elections Office (254-757-5043) and staff will alert voter center election workers.

#### **MISCELLANEOUS TIPS**

• Voters may not use their phones to look up information in a vote center. Clip this article and the Make a Plan to Vote flier that is printed elsewhere in this issue to carry with you to the vote center so you are prepared. Go to Vote411.org to learn what races you can vote in.

• Voters have been concerned about ballots with marks being disqualified or not counted. Voters should not be concerned about this. In McLennan County, every ballot must be signed by the election judge for each vote center. Once the voter marks his/her ballot, he/she will take it directly to the scanner. Thus, the last person to touch a ballot will be the voter.

 Voters are concerned about the law forbidding individuals from driving seven or more folks to a vote center. The remedy? Take six people to vote.


that education is not just about knowledge acquisition but also about building confidence and character. Through mentorship and support, she inspires students to overcome obstacles and strive for excellence.

### PROSTATE CANCER AWARENESS MONTH PANEL DISCUSSION

September was National Prostate Cancer month. The statistics show that Black men in this nation have a higher incidence of developing prostate cancer (1 out of 6), in their lifetime. It's more likely that it will be diagnosed at an advanced stage, which can lead to death. Together, with early intervention, it's very possible to turn the statistics around. Dr. Rodney Duckett has teamed up with three survivors of prostate cancer to educate the community about prostate cancer screening, treatment, and recovery. The panel discussion, held at the Killeen Civic and Conference Center, September 29, 2024 was open to the public.

Babatunde. Vietnam Veteran, entrepreneur, journalist, father, grandfather, diagnosed in 2021, cancer free, 2023. Ricky Green, journalist, husband, social media developer, diagnosed 2019, free of cancer, 2022. Jesse Johnson, medical and healthcare professional, began screening at the age 35, diagnosed in 2018, cancer free since 2019. Each man contributes a lot of time serving the community, maintaining active lifestyles, and are in healthy relationships.

Three types of screening are necessary to accurately

detect prostate cancer. Your urologist may require a physical exam, but ask for a blood test, and digital screening. Typically screening is scheduled at the age of 50. Due to a higher incidence among Black men, it's better to start earlier, ages 35-40. If there's a possibility of genetically inheriting cancerous genes, genetic testing is available, though it may not be covered by insurance. From the blood test, you will receive a prostatespecific antigen or PSA reading, which is made by a protein in the gland. If that level is high, a biopsy will be needed. The PSA should be part of the annual visit. If it rises to 4, it may be wise to consider options for more testing. The Gleason test has a range of 5-10. If the Gleason test is 5 or above, cancer is present. The Gleason numbers determine the rate of growth and possible spreading. Babatunde states, "You have to be a part of what's happening. I had a urologist for years, and I was told something should have been done at 4. Within four

months my PSA count had changed. With any test, I say, trust your doctor and verify the test." According to Jesse Johnson, "I had a good doctor, knew my medical history, and was proactive about my health when I found a lump. I first began screening at the age 35. At 52, my PSA went from a single digit to double. Your PSA may show one thing and the digital something else. If your medical or family history warrants, get a biopsy earlier. Screening is less than an hour. Bring your support person because you have to pray, gather information, while trying to process and make a decision." Ricky Green recalls, "I faithfully went to my doctor. I was being tested so I could donate a kidney to my sister and that's when I learned about my diagnosis. I got my annual physicals, bloodwork, but checking my PSA wasn't a part of the routine. I was 53 when I was diagnosed. As an athlete. I had to have physical exams and get checked once a year. This is the same. Get the bloodwork.

Once diagnosed, decisions about treatment plans must be made. Every situation comes with its own set of complexities. One option is radiation, which can stop cancer from spreading. Radiation may require short daily visits to stop the spread along with hormone replacement therapy. Babatunde says, "3 months following radiation, I had to have another PSA test, and continually every 90 days." There are side effects after treatment, and solutions to ensure your quality of life is manageable. For Jesse Johnson, healing took about 3 months following surgery. In the midst of an epidemic, he found himself having to confront his mortality during the most isolating time in history. He recalls, "I was working. My life was dedicated to my wife and kids, now I had to face my own mortality. I was basically existing, putting myself last. With the diagnosis, I had to prepare for a lifetime of changes and prepare myself mentally. My doctor asked, "How's the relationship because it's going to change." Treatment options following surgery include injections, electronic therapy, implants, medication, and exercises. Insurance may cover some of the treatments and therapy. Be patient. The objective is to say, I'm Alive! Ricky Green explains, "There's fear associated with healthcare. What insurance doesn't cover, programs are available to receive. As a patient, you have to know your rights and know your body. I was shocked when I learned I had cancer. I found out there were options other than surgery. Having that bloodwork done is vital. You have to get a doctor, and it's good to find one you connect with, someone who has compassion, an urgency about your treatment, and care"

All of the men expressed the ordeal of having to endure the wait, diagnosis, and finding appropriate treatments. In addition to city and county health resources, financial sources are available. Ricky used group funding. He said, "I was afraid, embarrassed... but this is life and death. It required me to be proactive. There are people out there wanting to help." Jesse states, "I see who really loves me. I'm a stronger person who lives a life of appreciation. You've got to let people help you. Ask your doctor for permission to record the conversation because it's a lot to process." Ricky spoke about the benefits of finding support. "Your social worker, primary care physician will help you inform you of appropriate group supports for your needs. Understand, you may find yourself alone." Babatunde, "I want to make sure black men in particular go get early screening. Special thanks to Dr. Duckett for creating a safe and open environment for men and their families to learn, share, and support one another. Get screened today.'

# WHAT IS THE MEDICARE ANNUAL ENROLLMENT PERIOD?

Today, we will review the Medicare Annual Enrollment Period, which is also called the AEP. This period is always October 15th to December 7th of each year.

This is the time when all Medicare recipients can make changes. They can enroll or dis-enroll from a Medicare Advantage or Prescription Drug Plan for the upcoming year. The effective date for AEP selections will be January 1, 2025.

Medicare Plan Companies may be adjusting benefits, premiums or copays for the upcoming year. It is wise to have an annual review to see what changes may have been made to your current plan so you can decide to either keep that plan or change plans.

Your doctors are also able to decide from year to year, if they will still be in the network or if they will be out of the network. If you have chosen a Medicare HMO plan, making certain that your doctor is in the network is imperative. If you have chosen a Medicare PPO or SNP

plans, you may pay more if your doctor is out of the network.

Agents and brokers cannot discuss the new 2025 plans or take applications for these plans until the AEP but you can begin setting up appointments after October 1, 2024

During your appointment, together we will review your doctor(s) selection; we will review your current medications to make certain that they are on the Plan Formulary or List of Drugs; we will see if a Special Needs Plan

would be a good choice for you or if you qualify for a Medicare Medicaid plan.

If you are on Medicare but have an employer retiree plan, a thorough analysis will be done to determine if continuing on your employer plan or changing to a Medicare plan would be the best choice for you.

Call me after October 1st to set up an Annual Enrollment Period appointment to learn the available options in McLennan County for 2025.

### THE ELECTION IS FINALLY HERE!

The Election is finally here. Absentee Ballots are starting to go out. Election Workers and the Elections Office are preparing. The last Day to Register to vote is October 7th. Early voting begins on October 21st and runs until November 1st. The last Day to apply for a Ballot by Mail is October 25th. Election Day is 5 November.

Please exercise your right to vote in the upcoming Election, November 5th. If you don't vote, your voice is not heard. We here at the McLennan County Democratic Party believe first and foremost in Democracy. We want everyone, even those who may disagree with us, to vote. Here are a few of the important things you need to know.

If you receive a Ballot by Mail, be sure to fill it out and return it immediately. It must be received by the Elections Office by Election Day, November the 5th. Send it right away to ensure that it has time to get through the mail and to be processed. Place both the last 4 digits of your Social Security Number and your driver's license number in the indicated places to avoid any possible confusion. If you fail to mail it in time, you can still vote. You can bring the ballot to a Vote Center, get it cancelled and vote in person.

There are 5 Early Vote Centers during Early Voting October 21st through November 1st. On Election Day, November 5th, there are 46 Vote Centers in McLennan County. You can vote at any location near your home or your work wherever in McLennan County you happen to be. To find the list of polling places, go to McLennanvotes.org.

You will need to bring an ID to the Vote Center so that Election Workers can check to see if you are registered. Most people use their Drivers License but there are alternatives. Go to VoteTexas.gov » Voter ID to see them all.

If you are registered and you do hot have any of the acceptable forms of ID, you may still be able to vote. Bring your utility bill, government check, bank statement, birth certificate, pay check or some other official document with your name. You will have to fill out a Statement of Reasonable Impairment.No one who truly believes they are registered to vote should be turned away at the polls.

If all else fails, request a Provisional Ballot. This will force the Elections Office to double check to see if you are registered and you will have 6 calendar days to bring in additional proof.

When you go to vote, we hope you will vote for our Democratic candidates. The Republican Party, which has controlled Texas politics for a generation has drifted into extremism. They now spend most of their time blaming and attacking people rather than offering policies that help people. They are the party of fear and they want you to be afraid. They are afraid of Women. 
days spoken unto us by his Son, whom he hath appointed heir of all things, by whom also he made the worlds): The new testament is where God speaks to today's church.

### **EQUALITY OF THE SEXES**

Women have been oppressed for centuries.

Denied personal safety, independence, education, the vote, political power, property rights and even control over their own bodies, minds and destinies, women have suffered the consequences of inequality in most societies around the world since the beginning of recorded history.

demonstrate the equality of capacity of both for achievement and advancement. ...Divine Justice demands that the rights of both sexes should be equally respected since neither is superior to the other in the eyes of Heaven. Human virtues belong equally to all!"

Bahá'ís have promoted the equality of the sexes since our Faith's inception in the middle of the 19th Century. In Persia, where the Bahá'í Faith had its beginnings, unequal treatment of women was well-documented and particularly oppressive – and when the Bahá'í Faith began, this fundamental principle of gender equality gen-

erated enormous controversy and persecution. Even today, Bahá'í s are imprisoned in Iran for their advocacy of gender equality and other progressive Bahá'í teachings.

But the Bahá'í approach to achieving gender equality in the world has a unique aspect. A century ago 'Abdu'l-Bahá actively encouraged movements for the equality of women – by asking men to take responsibility for the issue:

"Women must endeavor then to be men's equal in every respect, to make progress in all in which she has been held back, so that men will be compelled to acknowledge her equality of capacity and attainment. God's Bounty is for all and gives power for all progress. When men own the equality of women there will be no need for them to struggle for their rights!"

That phrase – "When men own the equality of women" – calls for a radical new take on the issue of equality. It asks men to become the advocates of women; to stand up for their rights.

With lightning speed, I dashed out the backdoor, tripping over the threshold, but still holding my balance and determination. Thank God my boy was spending the night with a friend. It was pitch-black dark outside, as I had no time to flip on the outside lights. I just needed to get out. Once inside my car, I let out a sigh, unaware that I had been holding my breath. Quickly locking the car doors, I knew I was on my way. The car was run down and bent up, but it was my path to freedom tonight and my only means of transportation. I'll never forget it. It was a gray and black Toyota, well....a fading gray and a fading black, a hatchback, about 8 years old at the time, and a stick. Ha! A stick. That could be a holdup since I was still in the learning stage, but I could handle it. I tried to crank the old trap, but it just clicked. I tried again, combining my efforts with a plea. "Please God, I need my car!" Just as the motor turned over, I heard that dreadful sound, a swatch-type sound, like an old screen door dragging. My God! He knew I was going to try to get away. He

knew, so he had unlocked the hatch back, ahead of time! He was in the back so fast; all I could do was bite my lip and jerk forward. "Stop the car, Lynn, and give me the money!" he yelled, as he swiftly crawled into the back seat. He lurched through the bucket seats so fast that my head literally seemed to spin, like the girl in the Exorcist. Grabbing the steering wheel, he yelled again, "Gimme the money, Lynn!" The Exorcist...I was sure that his voice changed. But tonight...no, not tonight. I kept driving, the car swerving across into the other the lane and back again as he, too, gripped the wheel. We came within inches of hitting a minivan. I saw head lights

of an 18 wheeler that we also barely missed as we sped into the on-coming traffic. Hands pinned to the wheel, I was driving to my pastor's house, and no one was stopping me. That was the life I lived for most of my 16 years of marriage to a crack addict, one that was much different from my single days of the quiet, country, church girl. I had never touched drugs in my life. I smoked only one cigarette that nearly killed me. And here I was, 29 years old, married to a drug addict. I had so many similar stories to contend with, jumping fences to get my car back from the drug dealers, standing toe- totoe and nose-to-nose with dealers who threatened to kill me if I didn't leave them alone about getting my car back, knocks on the door in the middle of the night from thugs demanding money my husband owed them, stealing my own car back and driving backwards, trying to miss the flying bullets. You name it; I just about dealt with it. Many times over the years, I walked into my house to find that every piece of furniture and every appliance was gonesold in exchange for drugs. I remember waking up one Christmas Day to find that

my babies' gifts were gone, sold for drugs. Once, I frantically searched the streets of Tampa because my husband put our 6-year-old out of the car since it was "too dangerous to take him to the crack house," he said. This was before the days of cell phones. I don't even remember how I found my baby boy. I could go on and on, but the only thing that matters is that one day, I accepted the truth that I had to forgive if I expected to move on with my life. I have since come to grips with the truth, that my now ex-husband was a good person, who loved people. When he was straight, he would give away his last. When he was not, he would take another person's last. I literally saw him take his shirt off and give it away. Once he pulled off his watch and gave it away, and then took my watch and gave it away, too. He had a heart of gold, but in addiction, he was the devil. Still, I had to find a way to forgive. I owed it to myself, my children, and my God.
